GENERAL USE: Use as a spot or crack and crevice treatment to control cockroaches, silverfish, ticks, fleas and other insects listed below. Apply this product as a coarse spray to localized areas where pests are found and may occur. Spray surfaces until wet. Repeat as needed.

TO CONTROL OUTDOOR PESTS: Kills cockroaches, ants, crickets, silverfish, spiders, sowbugs, earwigs, fleas, flies, black flies and mosquitoes. Use only out of doors for treatment around the outside surface of windows and door frames and areas where flies and mosquitoes enter the home.

TO CONTROL INDOOR PESTS: Kills cockroaches, ants, crickets, silverfish, spiders, sowbugs, earwigs, fleas and carpet beetles. Apply as a coarse spray where these pests are found or may hide,

including dark corners or rooms and closets. Thoroughly treat cracks and crevices in walls, along baseboards and door and window frames, moist areas such as spaces around water pipes and tanks, surfaces behind and beneath cabinets and storage areas, refrigerators, sinks, stoves and around garbage storage areas. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, around door frames, windows and sills and along baseboards adjacent to them. Pay particular attention to cracks and crevices. Do not use as a space spray. Good sanitary practices should be maintained to prevent re-infestation. For carpet beetles, thoroughly apply as a spot treatment along baseboards and edges of carpeting, rugs and furniture.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contact with skin, eyes and clothing. Do not use as a space spray. Do not allow spray to contact food, feedstuffs and water supplies. In homes and dwellings, remove or cover all exposed foods and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before reuse. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls before spraying. Avoid inhalation of spray. Wash with soap and water after using.

DISPOSAL: Do not reuse empty container. Wrap container and dispose in household garbage.

TOXICOLOGY AND FIRST AID: Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal. Obtain medical attention immediately, taking pesticide container with you. If in eyes or on skin, flush with clear water. If irritation persists, obtain medical attention. If accidentally swallowed, drink one or two glasses of water and induce vomiting by touching back of throat with finger and obtain medical attention at once.
