Ants, Cockroaches, Crickets, Earwigs, Silverfish: Apply as a coarse spray or with a paint brush to baseboards, areas around water pipes, cracks and crevices, surfaces beyond and beneath cabinets, refrigerators, sinks, stoves, undersides of table tops and shelving and similar areas where these insects nest or hide. Remove or cover all food and utensils before treatment. After spraying, wash all surfaces that may contact food, and rinse thoroughly with potable water before resuming operations.

Clover Mites: Apply as a coarse spray or with a paint brush to window and door frames and sills, along baseboards and the floor close to them. Pay particular attention to all cracks and crevices.

Brown Dog Ticks, Fleas: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, animal sleeping quarters and localized areas of floors and floor coverings. Fresh bedding should be placed in animal quarters following treatment.
