DANGER!

DIRECTIONS FOR USE

PULP AND PAPER

Metasol CMI-150-C is recommended for the control of bacterial and fungal slime in the production of paper.

POINT OF ADDITION: Metasol CMI-150-C should be added at a point in the system to insure uniform mixing such as the Beater, Hydropulper or Fan or Broke Storage Pumps.

DOSAGE: Apply 0.3 to 1.1 kgs. of Metasol CMI-150-C as supplied per tonne (dry basis) of pulp or paper produced, as a slug dose. If needed repeat daily. Badly fouled systems should be cleaned before initial treatment. One litre of Metasol CMI-150-C weighs 1.01 kg.

STORAGE AND DISPOSAL

DISPOSAL:

- 1) Rinse the emptied container thoroughly and add the rinsings to treatment site.
- 2) Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3) Make the empty container unsuitable for further use.
- 4) Dispose of the container in accordance with provincial requirements.
- 5) For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the manufacturer.
