TO USE: Pierce the protective film with a sharp object to expose the attractive seed. Place one tray (20 grams) of bait at 3-4 meter intervals in areas where there are signs of mice. Bromone Canary Seed Mouse Bait should be placed in tamper-resistant boxes or in protected areas, inaccessible to humans, pets, fowl, and domestic animals, behind boards next to the wall, between walls and in mouse holes. Maintain a supply of mouse bait as long as there is evidence of feeding (at least 15 days). Use more trays for heavy infestations.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contact between bait and eyes, mouth, skin or clothing. Sanex Bromone

Canary Seed Mouse Bait contains as its active ingredient an anti-coagulant chemical which, if taken internally by humans, domestic animals or pets, may reduce the clotting ability of the blood, and internal haemorrhage may result.

FIRST AID: In case of accidental consumption insert a finger into the throat to induce vomiting. Call a physician or Poison Control Centre immediately.

TOXICOLOGICAL INFORMATION: If swallowed by humans, domestic animals or pets, this material may reduce the clotting ability of the blood and cause bleeding. Vitamin K₁ in the form of intravenous, intramuscular or subcutaneous injections, or by oral ingestion are suggested remedial treatments for anticoagulant poisoning. The severity of the case measured by establishing prolonged prothrombin times (P.T.), will determine appropriate therapy. Monitoring P.T. will include the necessity of repeated treatments.
