DIRECTIONS:

To kill fleas and ticks, including the Deer Tick, which may carry the organism which causes Lyme Disease, wet dog's coat thoroughly with water and rub shampoo into coat starting at head. Keep away from animal's eyes. Work backward until coat is completely covered with foamy lather. Let lather stay on for 5 minutes, then rinse and towel dry. Repeat as required. Wash hands after use.

For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

PRECAUTIONS:

Avoid contact with eyes. Consult a veterinarian before using on pregnant or sick animals, or animals under drug or other pesticide treatment. It is not advisable to use this product or similar pesticides on nursing animals or puppies under 8 weeks of age. Discontinue use if adverse effects are observed. Do not use near birds or fish.

FIRST AID:

If in eyes, flush with clean water. If irritation persists, or if ingested, obtain medical attention or call Poison Control Centre.

DISPOSAL:

Do not reuse empty container. Wrap container and put in household garbage.
