DIRECTIONS FOR USE:

GENERAL INFORMATION: **OMITE-30W** is not systemic in action; therefore, complete coverage of both upper and lower leaf surfaces and of fruit is necessary for effective control. A minimum daily average temperature of 20°C is required for optimum Mite control. Do not apply **OMITE-30W** when air temperature is above 35°C. When applying as a dilute mixture, spray until the foliage drips. This product is compatible with most commonly used insecticides and fungicides except Guthion EC oil, Bordeaux lime & lime sulphur. Do not use more than 250 mL of additional spray adjuvant per 1000 litres if **OMITE-30W** is used alone. Add no spray adjuvant if **OMITE-30W** is mixed with one or more pesticide formulations in the spray

tank. Do not use **OMITE-30W** with Diazinon or Guthion WP where air temperatures are above 30°C.

VOLUME OF WATER: Dilute sprays (eg 3-4000L/ha) are preferred for the application of **OMITE-30W**. Concentrated sprays may be used if care is taken to ensure thorough and complete coverage of upper and lower surfaces of foliage and fruit. The more concentrated the spray, the higher the probability of uneven coverage. Use well-calibrated, efficient equipment coupled with careful operation.

RATE OF APPLICATION: Calculate the rate of **OMITE-30W** to be used from the tables that follow. Use this rate in kilograms in the volume per hectare required to give complete coverage with your equipment. Do not reduce the rate of **OMITE-30W** below recommendations and never exceed the maximums given. The rates given allow for adjustment according to density, size and vigor of trees.

HOPS European Red Two spotted		Apply 1-2 times per year. Do not apply later than 14 days before harvest.	[5.5 kg ha]

USE RESTRICTIONS:

1. This product is toxic to fish. Do not contaminate ponds, lakes or streams.
2. Avoid contamination of feed or food.
3. Do not use on crops other than those listed on this label.
4. Do not graze animals on cover crops in orchards and vineyards sprayed with **OMITE**.
5. Do not feed pomace from **OMITE** treated fruit to livestock.

6. Store product in a cool, dry place do not freeze.

SAFETY PRECAUTIONS:

1. KEEP OUT OF REACH OF CHILDREN.
2. Corrosive. Can cause skin and eye damage.

FIRST AID:

IF ON SKIN: Immediately flush skin with plenty of water for at least 15 minutes. Remove and wash contaminated clothing before reuse.
