DIRECTIONS FOR USE

Apply TORDON 10K PELLETS brush killer in the spring or early summer before growth begins or during vigorous growth and when abundant moisture can be expected. Distribute TORDON 10K PELLETS uniformly as a spot or broadcast treatment to the soil over the roots of woody plants. Use ground or aerial application equipment as directed below.

Spot Treatment:

Spot application is generally the preferred method of treatment for scattered or sparse stands of brush. Spread TORDON 10K PELLETS evenly on the soil over the entire root system (around the main stem) and outward to 30 cm beyond the branch tips (drip-line) as shown in the illustration. Use at the rate of 100 to 200 g per 10m<sup>2</sup> of soil surface.

Broadcast Treatment:

Broadcast treatment is the preferred method of treatment for dense stands of brush.

Rate of Application

Brush	Application Rate (kg product/ha)
Birch, poplar, cedar, basswood, pincherry, willow, wild rose and other susceptible species	40-50
Alder, maple, fir, spruce, pine	50-60
Tamarack, oak, blackgum	95

Use the higher rate for very dense stands of brush.

Ground application:

Use TORDON 10K PELLETS at the rate of 40 to 95 kg/ha (approximately 400 to 950 g/100m<sup>2</sup>) and distribute evenly over the entire area where brush is to be controlled.

Aerial application:

Apply TORDON 10K PELLETS to electrical rights-of-way, military bases, pipelines and firebreaks at a rate of 40-95 kg/ha. Do not apply by air in other locations.

USE PRECAUTIONS

**SENSITIVE PLANTS:** Apply only as recommended to avoid injury to desirable plants. Avoid applications during windy periods when the product may be blown away from the area being treated or onto parts of desirable plants. Care must be taken to avoid contaminating any bodies of water. Where applicable, observe any local buffer zone or setback requirements.

**STORAGE:** Do not store near food, feedstuff, seeds, insecticides, fungicides and other pesticides or herbicides intended to be used on TORDON sensitive plants.

**EQUIPMENT CLEAN-UP:** Equipment used for applying TORDON 10K PELLETS brush killer should not be used for applying other materials to desirable plants. Clean equipment away from areas where the chemical or rinse water may contact the roots of desirable trees or plants.

**CONTAINER DISPOSAL:** The shipping container should not be reused. Dispose of empty container by burning or crushing and burying in non-cropland away from desirable plants or water supplies or deliver to an approved pesticide container disposal site.

**NOTE:** Be sure that all use of TORDON 10K PELLETS brush killer conforms to local regulations.
