DIRECTIONS FOR USE:

For the control of hard shelled insects such as: silverfish, cockroaches, flour weevils, beetles etc. Apply at the rate of 200 millilitres per 100 cubic metres, using a hand sprayer or similar equipment (not a fogger). Apply spray into all cracks, crevices and hiding places such as baseboards, moist areas, openings around sinks, drains, and pipes, behind cabinets, and in storage areas. Insects must be contacted by spray to be killed. Leave room closed for 20 - 30 minutes. Do not remain in treated areas.

For the control of flying insects such as mosquitoes, flies, gnats, wasps, moths or other small flying insects, apply at the rate of 100 millilitres per

100 cubic metres with suitable fog generating equipment.

For best results, close all doors and windows and shut off ventilating systems during treatment. Remove all animals from treatment area before using as a space spray.

Direct spray upwards to all parts of the room, especially windows and other light sources. Also direct mist into areas where insects are present. Spray only when temperature is under 32 degrees C. Keep area sealed for 30 minutes after each treatment.

Do not remain in treated areas. Ventilate treated areas thoroughly for at least 30 minutes before animal re-entry. Ensure proper ventilation after sealed areas have been treated. Following ventilation, clean up dead insects.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. FLAMMABLE MIXTURE. Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water or food stuffs. In food processing plants and food service establishments, apply only when plant is NOT in operation.

Do not use near birds, fish or pets. Do not spray on plastic or varnished surfaces. Do not spray closer than 1 m to fabric. Dispose of empty container in regular garbage.
