container 15 to 25 centimetres from the animal and spray lightly  
over the entire body. Do not spray in eyes. For best

penetration of spray to the skin, direct spray against the natural lay of the hair to cause fluffing of the coat. Repeat as necessary but not more than once weekly. Sendran Spray provides rapid kill of fleas on dogs and cats and ticks on dogs. For more prolonged insect control, the animal's bedding should be treated to help prevent reinfestation.

PRECAUTIONS: Keep out of reach of children. Harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of treatment area. Contact with skin, eyes or clothing should also be avoided. Wash thoroughly with soap and warm water after handling. Avoid contamination of food, utensils and food preparation area.

FLAMMABLE: Do not spray into or near open flame. Do not smoke while using. Keep container away from stoves, radiators and other hot surfaces. Do not place in direct sunlight. Temperatures exceeding 49°C may cause container to burst. Contents under pressure. Do not puncture or incinerate container. Keep in cool, dry place.

FIRST AID: If swallowed, do not induce vomiting. If illness should occur, obtain prompt medical aid.

TOXICOLOGY: Large dose of active ingredient will result in cholinesterase depression. Atropine sulfate is antidotal. Do not give morphine. Watch for delayed pulmonary edema in cases of serious poisoning. In this case, use oxygen therapy and treat symptomatically.
