DIRECTIONS FOR USE

1. Initial dosage for spa water having no visible algae is 15 mL of Algae Free for Spas per 1000 L of spa water.
2. Weekly maintenance dosage is 5 mL per 1000 L.
3. For spa water having visible algae, superchlorinate, and wait for at least 24 hours before adding weekly maintenance dosage.
4. For visible algae, when superchlorination is not employed, add 20 mL of Algae Free for Spas per 1000 L of spa water.
5. For proper sanitation, spa must be completely drained periodically. The number of days between COMPLETE SPA DRAINAGE is equal to the volume of spa water in litres, divided by 10 times the Maximum Number of daily spa users. Refill spa with water and repeat DIRECTIONS FOR USE.
6. Maximum spa water usage temperature is 40C. Duration in spa water at 40C should not exceed 15 minutes.
