BARTLETT ROPELLENT

Bartlett "Ropellent" is a formula expressly manufactured for the protection of TREES SHRUBS, etc. against injury by rabbits and rodents.

NOTE : Allow no weed or suckers to grow at the base of the tree, shrub, etc. Either spray with orchard weed killer chemicals or clean by hoeing or mowing.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Avoid contact with skin, eyes, and clothing. Wash after handling and before eating, drinking, or smoking. Do not contaminate food or feed. Do not consume alcoholic beverages immediately before or within 24 hours after working with Thiram. Keep container closed to prevent evaporation.

KEEP FROM FROST.

FIRST AID : If on skin, wash with plenty of water. IF in eyes, flush with water for 5-10 minutes and get medical attention. If swallowed, induce vomiting and have the victim consume milk or white of egg.

DISPOSAL : Rinse the emptied container thorough and add the rinsings to the spray mixture in the tank. Follow provincial instruction for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product an the cleanup of spills, contact the Provincial Regulatory agency or the Manufacturer.

DIRECTIONS

Mix well before using.

May be applied as a Brush Coat or Spray.

One L of Bartlett "Ropellent" will brush coat approximately 45-55 trees 2-3 cm in diameter.

BRUSH COAT

Apply directly from container. Use either a paint brush or car washing type mitten, with rubber gloves. Brush on trunk and main scaffold limbs of established trees to soil level and as high as rabbits can reach under severe snow conditions.

ONE APPLICATION IN THE FALL WILL GUARD
YOUR TREES FOR THE WINTER SEASON.

Apply on a bright day when temperature is above 0EC. (32EF). Do not apply if air temperature is under 0EC (32EF), or if rain is forecast.

SPRAY

Mix one part BARTLETT "ROPELLENT" with one part water. Apply with small sprayer covering all exposed parts of tree, shrubs, etc.

NOTE : Trees, shrubs, etc. should be checked in early spring. A second spray application may be required to assure protection until alternate food sources are available.
