Wood should be clean and dry, free of paint, varnish, grease or oil. Do not dilute. Apply by brush or dip 2 to 4 mins. per cm of thickness (6 to 12 mins. for dressed lumber). Second coat may be applied for high decay hazard: allow 8 hours between coats.

Approx. coverage: 4 sq. m (43 sq. ft.) per litre.

### FOR ROPE AND CANVAS

Immerse material until saturated. Dry for 24 hours before using. Do not use on rubberized materials.
