**DIRECTIONS FOR USE: SHAKE WELL BEFORE USE**. Hold can upright while spraying. Wasp and hornet nests: This product releases a fine jet that allows treatment of nests from one meter away. Treat at night or late evening when insects are inside the nest. Apply spray with 2-3 second bursts directly into the nest opening so that the liquid contacts the inside of the nest. If unable to spray directly into the nest, a heavy residual spray around and into the opening where insects gain entrance will eventually eliminate the pests. Repeat as necessary. Keep pets and children away from surface until dry.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. FLAMMABLE. Contents under pressure. Do not spray near open flame or spark. Do not smoke while using. Never set container in hot water, on stove, radiator, or place where temperature will exceed 50°C. Do not puncture or throw container into fire. Do not use as a space spray. Do not spray humans, animals, or plants. May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes, or clothing should also be avoided. Wash thoroughly after using. Avoid contamination of crops, feed, food, utensils, and food preparation areas. Wash contaminated clothing with soap and hot water before reuse.

Remove pets before spraying. Do not allow children or pets to come into contact with treated surfaces until they are dry. Avoid excessive wetting of plastic, rubber, and asphalt materials such as tiles and floor coverings.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If eyes are contaminated, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

## TOXICOLOGICAL INFORMATION:

This product contains a petroleum distillate. Vomiting may cause aspiration pneumonia. Propoxur is a carbamate which is a cholinesterase inhibitor. Typical symptoms of overexposure to cholinesterase inhibitors include malaise, muscle weakness, dizziness and sweating. Headache, salivation, nausea, vomiting, abdominal pain and diarrhea are often prominent. A life-threatening poisoning is signified by loss of consciousness, incontinence, convulsions and respiratory depression with a secondary cardiovascular component. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). However, if a blood sample is taken several hours after exposure, it is unlikely that blood cholinesterase activities will be depressed, due to rapid reactivation of cholinesterase. The antidote is atropine sulfate.

**DISPOSAL:** When container is empty, press button to release all pressure, then wrap and dispose of it in household garbage. Do not puncture or incinerate.
