DIRECTIONS FOR USE: ACTI-BROM 2599 may be applied using a bypass feeder or directly to the cooling water at any open section of the system where there is sufficient time and turbulence to completely dissolve the tablets before they enter the heat exchange area. Your Nalco representative will be able to assist in selecting such a feed point.

DOSAGE: When the system is noticeably fouled, add 1 to 3 kg/10,000 L of water in the system. Repeat initial dosage until 1 mg/L halogen residual, measured as free chlorine, is established for at least 4 hours. (Each tablet weighs 20 grams).

PRECAUTIONS: Corrosive to eyes. Do not get on skin, eyes or clothing. Wear safety glasses or goggles and rubber gloves when handling. Avoid generating or breathing dust. Remove and wash contaminated clothing before reuse.

FIRST AID: In case of contact wash off skin with plenty of water. For eyes, flush with water for 20 minutes holding eyelids open. Get medical attention. For ingestion, give water but do not induce vomiting. Get medical attention. Treat dust inhalation symptomatically.

DISPOSAL:

1. Close valve
2. Arrange for return of Porta-Feed.
3. For information on the disposal of unused, unwanted product and the cleanup of spills of contact the regional office of Environment Canada.
4. For small spills. Recover free liquid. Soak up residue with solids absorbent. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA AS IN # 3.
