REFILLABLE SYSTEM

DIRECTIONS: This product is to be used only to refill JAAB FLYING INSECT KILLER JRS AIRSPRAY (Reg. No: 25138) using the "JRS FILLER" apparatus.

REFILL PROCEDURE: (1) PRIMING THE PUMP: Open the pump outlet valve and ensure that all three tubes are inside the container

with inlet tube fully immersed in the liquid. (2) Prime the pump by cranking the handle until no air bubbles are seen in the outlet tube. (3) Close the outlet valve. (4) FILLING THE CAN: Remove the actuator from the empty can and place the can upside down on the holder. (5) Turn the latch to lock the can firmly in place. (6) Fill the can by cranking the handle until the pressure in the can has reached 100 p.s.i. (7) Remove the can and replace its actuator. (8) If more cans are required to be refilled then repeat steps 4 to 7. (9) PUMP CLEAN UP: Pull the inlet tube above the liquid level. (10) Open the outlet valve. (11) Crank the handle until no liquid or bubbles are seen in the inlet or outlet tube. (12) Remove the cap with tubes and place it immersed in water. (13) Replace the Bulk Refill container cap. (14) Flush the pump with water by cranking the handle several times. (15) Wipe the pump dry. (16) Store the pump and the bulk refill container in a safe place.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Wear Chemical resistant gloves and eye protection while refilling cans or handling bulk refill. Refill cans in a well ventilated area. Do not leave refill containers uncovered. Do not fill container while near open flame, spark or while smoking. Avoid breathing vapors. Wash hands thoroughly after handling.

**FIRST AID:** This product contains petroleum distillate. If ingested, do not induce vomiting. If person is conscious, wash out mouth and obtain medical attention or call poison control centre immediately. Do not give anything by mouth to an unconscious person.
