DIRECTIONS:

To Kill Cockroaches and Silverfish they must be hit by spray. Spray around refrigerators, sinks, all cabinets, around pantry shelves, into all cracks and crevices in moulding and woodwork, pipe openings in walls and floors or wherever these insects are likely to hide. Repeat treatment as often as necessary.

To Kill Bedbugs they must be hit by spray. Bedsteads should be sprayed thoroughly into all corners, crack and crevices. Springs and mattresses should be replaced or sprayed thoroughly after the bed is dismantled, paying particular attention to cracks, crevices, tufts and seams on mattresses, wallpaper that is loose, loose moulding and any place where the bugs may hide. Repeat treatment as often as necessary.

To Kill Flies, Mosquitoes and Gnats apply 100 to 200 ml of spray per 100 cubic metres. Close doors and windows directing the

spray up toward the ceiling. The room should be filled with mist and remain closed for 10-15 minutes. Ventilate for 1/2 hour prior to re-entry. Sweep up dead insects and destroy them. Repeat treatment as often as necessary.

To Kill Clothes Moths and Carpet Beetles take special precaution to see that cracks in floors and openings below base boards are wetted with spray liquid. Wool, lint and organic matter accumulating in these places will serve as breeding material for such pests. Clothing to be stored should be cleaned, aired and brushed and sprayed from a distance of 30 to 60 cm. Chests in which woollens are to be stored should be sprayed before being filled with clothes. Closets should be sprayed at least twice a month, directing the spray on and between the garments. Close for 1 hour after the treatment.

To Kill Fleas liberally spray to point of run off all infested places - rugs and under rugs, basements, under porches, and wherever pet animals make their bed. Replace or spray bedding or household pets. Do not spray animals directly. Repeat as required.

To Kill Ants use the spray so as to hit as many insects as possible, paying particular attention to nests, trails, runways and points of entry. Repeat treatment as often as necessary. Do not apply directly to plants.

In Meat Packing and Food Processing Plants spray only when plant is not in operation. No exposed meat products, ingredients or packaging materials are to be left in the room. Cover food handling equipment. Any treated surface that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing.

Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use and dispose in accordance with Provincial requirements. For information on the disposal of unused, unwanted product and the clean-up of spills, contact the Provincial Regulatory Agency or the Manufacturer.
