DIRECTIONS:

FOR CONTROL OF GRAIN INSECTS

Granary Weevils, Meal Moths, Chocolate Moths, Confused Flour Beetles, Saw Toothed Grain Beetles, Cigarette Beetles, Flat Grain Beetles: To kill the exposed stages of these pests use DISVAP 525 at the rate of 1.25 - 2.5 litres per 100 square meters and spray thoroughly walls, beams, ceilings, pipes, undersides of pallets, etc., so as to hit as many insects as possible and to effect a thorough coverage of all surfaces. During warm weather, weekly application should be made.

FOR CONTROL OF STRUCTURAL PESTS

Ants, Cockroaches, Silverfish, Spiders, Crickets: Treat infested areas around refrigerators, sinks, undersides of table tops and shelving, all cracks, crevices and baseboards, moulding and other hiding places. Apply also around all pipe openings through walls, floors, ceilings, and open cracks between tiles. Insects must be contacted to be killed.

FOR CONTROL OF FLYING INSECTS

Mosquitoes, Flies, Gnats, Wasps, Moths, Small Flying Insects

Space Spray: Close doors and windows. Shut off all ventilating systems. Prevent persons and animals from entering area. Direct mist upwards to all parts of the room especially windows and other light sources. Also direct mist into areas where insects are present. Apply DISVAP 525 at the rate of 40-80 mL per 100 m³ when using a machine that produces an aerosol mist and at no more than 200 mL per 100 m³ when using a thermal fog generator. The equipment must be operated and maintained in the manner prescribed on the instruction plate affixed to it and in accordance with the manufacturer's instruction manual and recommendations. Whenever possible, keep doors and windows closed for 30 minutes after each treatment. Keep spray at least 1 meter from interior walls, fabrics and furniture. Do not remain in treated area. Ventilate for 1 hour before reentry. Sweep up and destroy dead insects. Apply weekly or more often as infestation warrants.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contamination of food and feedstuffs. During operations ensure that all exposed products and utensils are covered. All fires, flames,

pilot lights and other sources of ignition must be extinguished. In meat packing and processing plants, only spray when plant is not in operation. No exposed meat products, ingredients or packaging materials to be left in the room, and cover feed handling equipment. Any treated surfaces that may contact meat food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing.

FIRST AID: If on skin, wash thoroughly with soap and water, if in eyes, flush with clean water. If irritation persists, obtain medical attention. If swallowed, obtain medical attention at once.

DISPOSAL: 1. Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the application device. 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. 3. Make the empty container unsuitable for further use. 4. Dispose of the container in accordance with provincial requirements. 5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environment Protection, Environment Canada.
