A prepared bait, in convenient Bait Bags, for the control of house mouse (*Mus musculus*), rood rat (*Rattus rattus*), and Norway rat (*Rattus norvegicus*) in dwellings, farm buildings, food service establishments, processing plants, storage area, feed and food processing plants, and outdoor areas around buildings, where food, fed and food and feed packaging materials are never open or exposed. RAT NIX will control the three species of rodents in as

little as one feeding, and will kill anticoagulant-resistant rats.

DIRECTIONS:

Place Bait Bags in inaccessible locations or in protected bait station in areas such as along walls, in corners, near rat holes, and in concealed areas where rats and mice feed, water or travel. Check daily to make sure that an uninterrupted supply of bait is available for at least 15 days. Continue baiting until all signs of feeding have stopped.

RATS: Place Bait Bags 6-9 m apart, 1-4 unopened Bait Bags per location.

MICE: Place Bait Bags 2-3 m apart, one unopened bag per location.

NOTE: If bait molds, decomposes or becomes sour, replace with fresh material.

IMPORTANT:

PLACE BAIT IN LOCATIONS WHICH ARE NOT ACCESSIBLE TO CHILDREN, PETS AND DOMESTIC ANIMALS OR PLACE IN TAMPER-PROOF BOXES.

In meat packing and food processing plants, use only when plant is not in operation. Remove or cover all food, packaging materials and utensils before placing baits. Remove all baits and dead rodents before re-use of plant for food processing.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Keep bait away from human beings, domestic animals and pets. Do not contaminate food or feed. Burn or bury bodies of dead rodents. In food processing plants, place bait in protected bait stations on the floor only; do not place in overhead locations. Wash thoroughly any tables, cutting blocks, or equipment accidentally contaminated. Do not apply bait during production hours or near open foodstuffs. If swallowed by human beings, domestic animals and pets, this product may reduce the clotting ability of the blood and cause internal bleeding. Do not contaminate any body of water.

FOR ALL CASES OF HUMAN INGESTION, IMMEDIATELY NOTIFY A PHYSICIAN.

FIRST AID:

If swallowed give patient one or two glasses of water and cause vomiting by inserting finger down the throat; repeat until vomit is clear. Call a physician.

TOXICOLOGICAL INFORMATION:

In case of accidental swallowing the intravenous and oral administration of Vitamin K1 combined with blood transfusions are indicated as in the case of haemorrhage caused by overdoses of dicumarol.

DISPOSAL AND DECONTAMINATION:

Do not re-use empty container. Container should be disposed of by punching holes in it and burying with wastes or by burning(keep out of smoke).

Burn or bury small amounts of surplus products or send to garbage dump in accordance with municipal requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection, Environment Canada.
