Avoid spraying interior walls, fabrics and furniture to prevent possible staining or fabric reaction (where possible, pretest prior to use). Keep doors and windows closed for 15 minutes after treatment. Ensure proper ventilation after sealed areas have been treated. Clean up and dispose of dead insects. Spray only when temperature is under 32'C.
