#### DIRECTIONS

LIGHT CLEANING: Wall washing, metal furniture, lockers etc., use 1:80 (12 mL per L) in warm water, rinse if surface is to be recoated with waxes or finishes; apply with mop.

REGULAR CLEANING: Daily floor maintenance, shower rooms, utensils, use 1:40 in warm water; rinse with clean water; apply with mop, applicator or cloth.

HEAVY CLEANING: Floor stripping, use 1:20 with warm water; apply with mop; allow to stand 10 minutes, machine scrub and rinse with clean water.

WASHROOMS: Urinals, wash basins, plumbing fixtures, use 1:20 of water, apply by pouring on mops. Allow to stand 5 minutes before flushing or rinsing. Does not have to be flushed.

FIRST AID: In case of eye or skin contact, flush with water for 15 minutes. For eyes, get medical attention.

CAUTIONS: Corrosive to eyes. May cause skin irritation. Avoid contact with eyes, skin or clothing. Keep out of reach of children.
