- If herbicide penetrates clothing, remove immediately, then wash thoroughly and put on clean clothing. Throw away clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate.
- After using this product, remove clothing and launder separately, and promptly and thoroughly wash hands and exposed skin with soap and water. DECONTAMINATION AND DISPOSAL:

- When all the water soluble bags are used, make the empty outer package unsuitable for further use.

DIRECTIONS FOR USE:

- KILLEX WSP is a specially formulated herbicide for the selective post-emergence control of many broadleaf weeds in turf.
- Maximum weed control will be obtained from spring or early fall applications when weeds are actively growing.
- Avoid applying during long, excessively dry or hot periods, unless adequate irrigation is available.
- Do not irrigate within 24 hours after application.
- Do not apply when the air temperature exceeds 29°C (85°F) as some turf injury may occur.
- Do not apply to newly seeded turf until after the second or third mowing.
- Grass seed can be safely sown 3-4 weeks after application.
- Do not use on bent grass varieties unless temporary discoloration or injury can be tolerated.
- MAXIMUM APPLICATION FREQUENCY: For good turf/lawn management,

normally two applications per year per treatment site are adequate. This does not include spot treatments.

MIXING AND APPLICATION DIRECTIONS:

1. Prepare only the amount of spray mixture which can be used the day that it will be sprayed.
2. Fill the spray tank with $\frac{1}{2}$ to $\frac{3}{4}$ of the required amount of water and begin agitation. Sufficient agitation during mixing and application is essential to evenly disperse KILLEX WSP in the spray solution.
3. Remove the required number of water soluble bags from the outer package. Drop, one at a time, the required number of unopened water soluble bags containing KILLEX WSP into the spray tank. Allow time for each bag to disperse completely before adding another water soluble bag. Maintain continuous agitation to

avoid separation.

4. Finally, add the balance of the required water volume and maintain agitation prior to and during the application.
5. Before beginning to spray, make sure KILLEX WSP has dispersed and water soluble bag has dissolved.
6. KILLEX WSP is compatible with liquid or water soluble fertilizers but a compatibility test is recommended before tank mixing it with any fertilizers. Follow all fertilizer label instructions.
7. Calibrate spray application equipment prior to use for the best results.
8. After using this product, clean the sprayer thoroughly before applying other pesticides. Sprayers which have contained KILLEX WSP should not be used to apply other pesticides to 2,4-D sensitive plants.
9. Do not apply this product through any type of irrigation system.
10. DO NOT APPLY BY AIR.
