### **DIRECTIONS FOR USE:**

SHAKE WELL BEFORE USING.

Fleas and Ticks: Hold can 90 cm from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture. One can will treat a surface area equivalent to approximately five 3.0 m x 3.0 m rooms. Avoid wetting furniture and carpeting. Do not use as a space spray. Care should be used when treating wood surfaces, as water spotting may occur. A fine mist applied uniformly is all that is necessary to kill fleas and ticks. DO

NOT TREAT PETS WITH THIS PRODUCT. For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets, and treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding

areas prior to treatment with this product. Be sure to treat pet bedding and other resting places, as these are primary hiding places for fleas and ticks. No need to remove pet bedding after treatment. If pest problem persists, a second application 2-3 weeks after the initial treatment may be necessary. DO NOT USE ON PETS. To kill cockroaches, silverfish, crickets, ants, centipedes, sowbugs, and spiders, apply directly to pests.

### **PRECAUTIONS**
