DIRECTIONS:

CO-OP Fruit and Shrub Wettable Powder can be applied as a spray by mixing with water or used directly on the trees as a dust.

SPRAY: Mix 12 grams of product per litre of spray required. Mixing thoroughly, apply as a medium spray to cover all surfaces of foliage and fruit. Do not apply when fruits are in full bloom.

DUST: Apply to give a thin coating uniformly over the entire tree.

KEEP OUT OF REACH OF CHILDREN. Exposure to this product may cause skin and eye irritation. If safety precautions listed below are followed, exposure will be significantly reduced or eliminated. Never handle material with bare hands. Use rubber gloves, do not use leather or cloth gloves. Wash hands, face and arms thoroughly after handling this product and before drinking, eating or smoking. Do not breathe spray mist or dust. When handling or applying, wear goggles and clothing that completely covers arms and legs to minimize exposure. Change contaminated clothing and wash thoroughly before re-use. If an accident occurs, remove contaminated clothing immediately and wash contaminated skin thoroughly with soap and water. necessary, do not apply within 30 days of the first one on plums and cherries. Do not apply on hot days (30 deg. C.). Do not contaminate feed or foodstuffs. This product will thin apples if applied within 25 days of fruit set. This is not normally a problem as long as the correct rate is used and the apple tree has set a normal number of fruit. Some thinning is beneficial under conditions of normal or heavy fruit set. Do not apply within 25 days of fruit set in year when few fruit are set.

FIRST AID:

In case of poisoning, call a physician immediately. IF ON SKIN, remove contaminated clothing and wash skin thoroughly with soap and water. IF IN EYES, flush with water for 5-10 minutes and obtain medical attention. IF SWALLOWED, give the patient one to two glasses of water and cause vomiting by giving one dose of syrup of ipecac*. If syrup of ipecac is not available, give the patient one to two glasses of water and cause vomiting by inserting a finger down the throat. Repeat with water until vomit fluid is clear. The patient should be lying down with the head below the level of the feet. DO NOT TRY TO CAUSE VOMITING IF THE PATIENT IS UNCONSCIOUS OR IN A CONVULSIVE STATE. *(15 mL)

Carbaryl is a cholinesterase inhibitor. Atropine is antidotal. DO NOT USE 2-PAM.
