DIRECTIONS FOR USE:

COOLING TOWERS: Add separately to system. Do NOT mix with other
chemicals. Badly fouled systems should be mechanically cleaned
before treatment is begun. Initial shock dosages of 40-50 mL per
1,000 L water in the system. Maintenance dose every 2-5 days or
as needed, 5-25 mL per 1,000 L of water in the system.

PRECAUTIONS: This formula may cause skin irritation or damage to eyes. Harmful if swallowed. Avoid contact with eyes, skin or clothing. Wear suitable eye protection and protective gloves when handling. Do NOT reuse empty container. Keep container closed when not in use.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Do not discharge effluent containing this active ingredient into lakes, streams, ponds estuaries, oceans, or public waters. Do not contaminate water by cleaning of equipment or disposal of wastes.
