BACK PANEL

DIRECTIONS FOR USE:

Turn adjustable nozzle back slightly and squeeze trigger to operate. Adjust nozzle to provide desired spray pattern. Spray infested surfaces until wet.

Cockroaches, Ants, Silverfish, Spiders, Crickets, Earwigs, Sowbugs, Millipedes, Centipedes	Spray places where these pests are found or may hide including cracks and crevices, behind and beneath sinks, stoves, refrigerators, cabinets, garbage cans, plumbing and other utility installations. Pests flushed out of hiding places should be sprayed directly. Treat ant trails, nests and points of entry such as around windows, door frames and sills. Repeat treatment if pests re-appear.
Carpet Beetles	Spray edges of carpeting, under carpeting and rugs. Make spot treatments to floor and baseboards. Repeat if pests re-appear.
Cluster Fly	Spray outside and inside surfaces of window frames and cracks and crevices where flies can enter in the fall. Spot treat indoors when flies first appear. Repeat as necessary.
Brown Dog Ticks and Fleas	Spray pet sleeping quarters thoroughly, also infested areas around baseboards, windows and door frames. Place fresh bedding in animal quarters after spraying. Repeat if pests re-appear. DO NOT TREAT ANIMALS.
Flies, Mosquitoes, Wasps and Small Moths (Outdoors)	Apply as an aid in reducing annoyance from these insects. Spray outside surfaces of screens and doors, or wherever these pests may enter room. DO NOT USE AS A SPACE SPRAY.
Flies, Ants (Outdoors)	Spray weeds and bushy non-crop areas around the home thoroughly. Avoid spraying desirable plants. For ants, thoroughly wet hills and runways. Repeat if pests re-appear.

PRECAUTIONS:

Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with eyes, skin, clothing and avoid inhalation of vapours or spray mist. Wash thoroughly after handling and before eating, drinking, etc. KEEP OUT OF THE REACH OF CHILDREN. Do not allow others such as children and pets on treatment area during application or to re-enter treated areas until spray has dried. Do not apply to plants, animals or humans. Remove pets and fishbowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact.

DO NOT CONTAMINATE FOODSTUFFS. Do not use in any area where food may be exposed. Do not use in food storage areas. Do not use in cupboards where food or cooking utensils are stored. In homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before re-use.

TOXICOLOGICAL INFORMATION:

Diazinon is a cholinesterase inhibitor. Atropine is antidotal.

FIRST AID:

In case of poisoning, obtain medical attention immediately, taking the pesticide container with you. If on skin, remove contaminated clothing and wash skin thoroughly with soap and water. If in eyes, flush with water for 5-10 minutes and obtain medical attention. If swallowed, give patient one to two glasses of water and induce vomiting. Repeat with water until vomit is clear. Do not cause vomiting if the patient is unconscious or in a convulsive state. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
