The treatment site must have effective containment and pollution abatement technology to insure that the pesticide is not released into the surrounding environment under normal operating conditions.

STORAGE AND DISPOSAL

STORAGE:

Do not store below 16°C. Optimum storage temperature of 16-32°C is recommended.

DISPOSAL:

- 1. Triple or pressure-rinse the emptied container thoroughly and add the rinsings to the treatment site.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3. Make the empty container unsuitable for further use.
- 4. Dispose of the container in accordance with provincial requirements.

PRODUCT

TROYSAN POLYPHASE FX-30 is a broad spectrum liquid, non-metallic fungicide, which is effective against a wide variety of fungal organisms.

USES:

The recommended use levels for TROYSAN POLYPHASE FX-30 in percentage by weight and parts per million (ppm) refer to the product TROYSAN POLYPHASE FX-30. In order to determine the most effective use level for TROYSAN POLYPHASE FX-30 in a given end use, field trials are suggested.

CUTTING OILS:

TROYSAN POLYPHASE FX-30 may be used in metal-working fluids to prevent fungal growth at concentrations of 0.1% - 0.5% (100-500 ppm). It should be added to the cutting fluid concentrate in amount sufficient to yield the desired concentration in the diluted composition. It is recommended that biocide levels be checked periodically as many cutting oils are unstable upon standing.

STORAGE AND HANDLING:

TROYSAN POLYPHASE FX-30 has a tendency to crystallize at low temperatures. Storage temperatures below 90'F (32'C) and above 32'F (0'C) are recommended. Store drums in an upright position. Do not reuse empty drums. Dispose of in accordance with label directions. Complete safety and handling information will be found in the Material Safety Data Sheet.
