IT DOES NOT HAVE TO BE EATEN AS IN THE CASE OF BAIT. THEREFORE GOOD RESULTS ARE OBTAINED BY APPLYING SPRAY TO AREAS ADJACENT TO SLUG HIDING PLACES, OVER WHICH SLUGS WILL BE MIGRATING TO FOOD SOURCES. DIRECTIONS FOR USE: SHAKE BEFORE USING. Apply at the rate of 100 mL per 100 m of line. Do not allow animals to graze on treated areas within 1-2 weeks. Neither rain nor watering will dissipate the product up to 4 weeks.

LAWN & ORNAMENTALS: Flip up spout and lightly squeeze a line around flower beds and lawn edges. Apply to areas frequented by slugs in early evening. Repeat application as required.

VEGETABLES: Apply a barrier ring around your vegetable garden to protect it from outside invasion. Rate of application is same as for ornamentals. DO NOT APPLY ON EDIBLE PART OF VEGETABLES.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN, POULTRY AND DOMESTIC ANIMALS. Avoid contamination of food or feedstuffs. Protect contents from freezing. Do not store in direct sunlight. Do not get in eyes. Do not store near food. Do not contaminate lakes, ponds, streams or rivers. When the bottle is empty, add 50-100 mL of water into the bottle, shake well and use it all.
