DIRECTIONS:

Later's Latox Systemic Insect Killer is absorbed by the leaves and enters into plant sap. The best time to apply is early morning or late evening. Avoid spraying when the temperature is above 27EC., or if high humidity prevails during the heat of the day. Begin application when insects first appear.

DO NOT USE ON FOOD CROPS, Chrysanthemums, Boston Ivy, Mock Orange, Chinese Elm, and Hawthorn. Do not spray seedlings and new growth. Do not use inside buildings.

HOW TO USE:

Mix 6 mL of Later's Latox in 1 L of water and spray plants and both sides of leaves thoroughly. Repeat after two weeks if problem persists.

For use around Homes, Lawns, Patios and Garbage Cans mix 10 mL of Later's Latox in 1 L of water to control Clover Mites, Ants, Black Widow Spiders, Crickets, Sowbugs, Earwigs, Boxelder Bugs. Do not use inside the house.
