DIRECTIONS: When used as directed, Fly Ban controls flies,  
mosquitoes, wasps, gnats, silverfish, cockroaches, ants, spiders,  
crickets, dog and cat fleas, bedbugs, adult moth and accessible  
stages of stored product insects. Shake well before use.

FLIES, MOSQUITOES, WASPS, GNATS, SILVERFISH, COCKROACHES, ANTS,  
SPIDERS, CRICKETS, FLEAS: Close doors and windows. Direct mist  
upwards to all parts of the room, especially windows and other  
light sources. Also direct mist into areas where insects are  
found. Keep the room closed for 30 minutes after each treatment.  
Ventilate well before re-entry.

CLOTHES MOTHS: Treat infested inclosures arranging clothing and

other articles so that the mist can circulate freely. Close treated area for 45 minutes. Do not spray closer than 1 metre to fabric. Exceeding dosage rates and bi-weekly applications may cause stain on fabrics furs and other materials.

BED BUGS: Take bed apart. Spray the frame and the springs, especially cracks and crevices where the insects may hide. Spray the mattress with particular attention to the tufts and seams. Also, spray, cracks, crevices, baseboards, and other possible hiding places in the room.

PRECAUTIONS: This dispenser contains liquid under pressure. Do not puncture, incinerate or expose to temperatures higher than 50'C. Do not store or use near fire or flame. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, food, or water. keep out of reach of children. Do not use near birds, fish or pets. Avoid exposure to skin and eyed. Do not inhale mist. Do not spray on plastic or varnished surfaces. Do not spray closer than one meter to fabric. Do not use on tiled floor or rubber backed rugs.

FIRST AID: If in eyes, flush with water. If on skin, wash thoroughly with soap and water. If irritation develops or persists, contact physician. In case of accidental ingestion obtain medical attention immediately.

TOXICOLOGY: Treatment for the various reactions is symptomatic.
