DIRECTIONS FOR USE: Attach spray bottle to garden hose by connecting coupling nut tightly to hose and turning until black arrow aligns with OFF position. Turn water on at faucet. Push dark green button up and turn bottle until button seats into notch 1 or 2 (see below). To start spraying, turn coupling nut to align black arrow with ON. To spray water only, or for storage purposes, turn bottle until dark green button clicks to "W" notch. To stop spraying, turn coupling nut to align black arrow with OFF.

APPLICATION:

Setting "W": Water only (no chemical). Storage Position.

Setting 1: Spray to wet all surfaces of foliage. Apply at first appearance of insects and repeat as required or at 7 day intervals. Do not apply within 7 days of harvest of edible crops - leaf lettuce, 14 days.

ROSES, FLOWERS, ORNAMENTALS, FRUITS & VEGETABLES - to control aphids, bagworm, beetles, budmoth, cabbage worm, caterpillars, codling moth, currant fruitworm, fruit moth, lacebug, leafhopper, leafminer, leafroller, mealybug, mites, pine shoot moth, plum curculio, pear psylla, potato beetle, plant bug, raspberry fruitworm, tent caterpillar, whitefly.

CAUTION: Injury may occur to African Violet, crassula, ferns, petunia, Sabina and Canaerti juniper, redmaple, McIntosh and Courtland apples, Bosc and Bartlett pears and Ribier grapes.

Setting 2: For SPRUCE BUDWORM - spray as soon as larvae appear.

For MOSQUITOES - apply 50 mL on 100 square metres of grass, weeds, shrubs, etc.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not get into eyes. Avoid contact with skin or inhaling spray mist. Wear protective gloves when spraying. Wash thoroughly after use. Avoid contaminating food or feed, ponds and streams. Toxic to fish and bees - Spray flowers in late evening. Avoid drift, spray when winds are calm.

DISPOSAL: Wrap and dispose of empty unit in regular garbage. NOT REFILLABLE. DO NOT REUSE.

KEEP FROM FREEZING.

FIRST AID: This product contains petroleum distillates; if swallowed, do not induce vomiting, give patient air and remove to hospital quickly. If on skin, wash thoroughly with soap and water. If in eyes, flush with water for 15 minutes and get medical attention.

TOXICOLOGY: Malathion is an organophosphorous. Cholinesterase inhibitor; atropine and 2-PAM are antidotal.
