DIRECTIONS FOR USE:

For the preservation of exterior seasoned wood products.
- For exterior use only. Not for use in dwellings.

- For above ground use only.
- Apply by brush only. Do not spray or dip.
- Do not use the preservative or treated wood where Copper Naphthenate may contaminate food, feed, or drinking water.
- Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax or any other coating that may prevent penetration.
- Allow to dry thoroughly before painting or recoating. Use caution with some paint finishes as they may cause bleeding.
- Use as supplied - do not dilute.
- Do not apply to wood or fabric or any surface where prolonged skin contact may occur.
- May be used on greenhouse and garden timbers in close contact with non-food producing plants only. Carrier solvent must be allowed to dry before introducing plants to prevent phototoxicity.

For Fabric Use

- For use only on exterior industrial fabric, duck cloth, awnings, etc.
- Do not use on rubber coated fabric.
- Apply by brush or swab only. Do not spray or dip.
