### DIRECTIONS:

Application should be made as a coarse spray (using a pressure sprayer with a large orifice to avoid misting) to base-boards, areas around water pipes, cracks and crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and other localized areas infested with insects. Repeat as necessary to maintain control.

### DISPOSAL:

Do not reuse container. Dispose of empty container in household garbage.

### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Do not use as a space spray. Avoid contamination of feed or food stuff. Avoid inhalation and skin contact. Wash all skin and surfaces after contact.
