DIRECTIONS FOR USE:

LAWNS - To control creeping buttercup, Dandelion (fall), Plantain, spotted catsear, and Horsetail, mix 45 - 90 mL of M.C.P.A AMINE 400 into 12 - 15 L of water and spray evenly on 100 m² of lawn. A watering can may be used for this rate of application. repeat as required. For best results, spray in early fall and late spring when the weather promotes active weed growth. Use with caution during long, hot, dry spells. Do not cut the grass for 4 days before or after spraying. Spray on warm, calm days at low pressure to avoid drift.

AVOID SPRAYING if rain is expected shortly. DO NOT WATER THE LAWN within 24 hours of application. Do not use on newly seeded lawns until the grass has been cut three times. Do not use treated grass clippings as a mulch on susceptible plants.
