A rodenticide concentrate for the preparation of bait for the control of house mouse, roof rat, and Norway rat in dwellings, farm buildings, food service establishments, granary bins (empty), processing plants (food, non-food, feed) and storage areas (feed, food, non-food).

BAIT PREPARATION:

Mix thoroughly one of concentrate with 19 parts, by weight, of suitable semipermanent bait material such as a cornmeal, rolled oats, nut crumbs, dogfood, meal or poultry mash. A small amount

(up to 5%) of a bland oil such as mineral oil or corn oil or an inedible oil may be used to prevent excessive dusting where the mixing has a tendency to dust.

DIRECTIONS:

FOR RAT CONTROL:

Place bait in shallow trays in inaccessible locations or in protected bait stations, in areas such as along walls, in corners, near rat holes, and in concealed areas where rats feed, water or travel. Bait location should be placed 6-9 meters apart. Use 60-450 grams of bait per station.

Maintain an uninterrupted supply of bait in the station for no less than 15 days. Baiting can be continued indefinitely where infestation by rats and mice is a problem.

FOR MOUSE CONTROL:

Place bait in bait trays in inaccessible locations, or in protected bait stations, in areas where mice feed, water or travel. Use 15-60 grams of bait at each location. Bait locations should be placed 2-3 meters apart. Maintain an uninterrupted supply of bait for at least 15 days.

NOTE:

If bait molds, decomposes or becomes sour, replace with fresh material.

IMPORTANT: PLACE BAIT IN LOCATIONS WHICH ARE NOT ACCESSIBLE TO CHILDREN, PETS, AND DOMESTIC ANIMALS OR PLACE BAIT IN TAMPER PROOF BOXES.

In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food processing.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Keep bait away from human beings,

domestic animals and from pets. Do not contaminate food or feed. Burn or bury bodies of dead rodents. In food processing plants, place bait in protected bait stations on the floor only. Do not place in overhead locations. Wash thoroughly any tables, cutting blocks or equipment accidentally contaminated. Do not apply bait during production hours or near open foodstuff. If swallowed by human beings, domestic animals and pets, this product may reduce the clotting ability of the blood and cause internal bleeding. Do not contaminate any body of water.

FOR ALL CASES OF HUMAN INGESTION, IMMEDIATELY NOTIFY A PHYSICIAN.

FIRST AID: If swallowed, give patient one or two glasses of water and cause vomiting by inserting finger down the throat; repeat until vomit is clear. Call a physician.

TOXICOLOGICAL INFORMATION: In case of accidental swallowing, the intravenous and oral administrations of Vitamin K1 combined with blood transfusions are indicated, as in the case of hemorrhage caused by over- doses of dicumarol.

DISPOSAL AND DECONTAMINATION: Do not re-use empty container. Container should be disposed of by punching holes in it and burying with wastes or by burning (keep out of smoke).

Burn or bury small amounts of surplus product or send to garbage dump in accordance with municipal requirements. For information about disposal of large amounts of surplus product, contact the regional office of the Environment Protection Service, Environment Canada.
