DIRECTIONS FOR USE TO CLEAN, SANITIZE AND DEODORIZE CARPETS:

Stream Extraction: Vacuum carpet thoroughly. Mix 16 mL of 82 Carpet Sanitizer per litre of water. Inject and extract as you would any steam cleaning shampoo. **Spin Bonnet (Bonnet Buff) Cleaning:** Vaccum carpet thoroughly. Mix 32 mL of 82 Carpet Sanitizer per litre of water. Spray on carpet at rate of 4.9 - 7.4 m²/Litre. **Heavy Duty Spin Bonnet (Bonnet Buff) Cleaning:** Vacuum carpet thoroughly. Mix 125 mL of 82 Carpet Sanitizer per litre of water. Spray on carpet at rate of 4.9 - 7.4 m²/Litre.
