# APPLICATION RATES

Apple: Scab, Frog-Eye Leaf Spot- 63 to 84 kilograms per hectare. Consult your provincial spray calendar for timing of applications. Do not apply within 7 days of harvest. Early season sprays may cause injury to foliage of Red Delicious, Winesap and other sensitive varieties.

Cherry (Sour, Sweet): Brown Rot, Leaf Spot (Shot Hole) - 42 to 50.5 kilograms per hectare. Apply to trees in pre-bloom, bloom, petal fall, shuck, first, second and third cover sprays, and immediately after harvest. Leaf injury may result to the Schmidt and Emperor Francis varieties of sweet cherry in post-bloom

sprays. May be applied up to 2 days before harvest of sweet cherries. May be applied up to 5 days before harvest of sour cherries.

**Peach:** Brown Rot and Scab - 42 to 50.5 kilograms per hectare. Apply in late pink, full bloom, petal fall, shuck fall, cover sprays. Continue applications through harvest if conditions favour brown rot. May be applied up to 2 days before harvest.

Potato Seed Piece Treatment: Brown-Eye Disease, Damping-Off - Use at a rate of 195 grams per 25 kilograms cut seed pieces (780 grams to 100 kilograms of cut seed pieces). Apply in a convenient container or by duster attachment over belt. Coat each seed piece evenly with a light film of dust. Treat pieces within 6 hours after cutting. If planting is to be delayed for a day or two, store treated seed pieces in open crates, and provide sufficient ventilation to allow cut surfaces to dry before bagging.

Tomatoes: Anthracnose, Septoria Leaf Spot - Apply 17 to 30 kilograms per hectare at the first sign of infection and repeat at 7 to 10 day intervals. Use 33.5 to 42 kilogram per hectare for severe infestations or on mature plants. May be applied up to 2 days before harvest.

Soil and Greenhouse Bench Treatment: Apply 600 to 975 grams per 100 square metres (84 kilogram per hectare). Work into upper 7.5 to 10 centimetres of soil before planting. For damp-off and root rot diseases of seedling and transplants of roses, other shrubs, flowers, lawnseed beds and vegetables such as beans, peas, celery, crucifers, eggplant, pepper and tomato.

Ornamentals: Rose-Black Spot; Carnation-Leaf Spot; Chrysanthemum-Botrytis Flower Blight, Septoria Leaf Spot - Apply to give even coverage of upper and lower leaf surfaces. Repeat at 7 to 10 day intervals as necessary.

Lawns, Turf (golf courses and sod farms only): Brown Patch, Damping-Off, Leaf Spot, Melting-Out, Root Rot - Use 975 to 1000 grams per 100 square metres. Begin treatments before infection occurs in early spring. Repeat intervals of 7 - 14 days throughout the summer. The maximum application rate to turf (golf courses, sod farms) is 47.5 kgs of Captan 10 Dust per hectare with a maximum seasonal rate of 95 kgs/hectare. DO not apply to home lawns, parks, schools, sports fields and other recreational areas.

Begonia (Tuberous), Daffodil, Dahlia, Gladiolus, Iris (Bulbous) Narcissus, Tulip: Damping-Off, Bulb Rots - Use 180 to 450 grams per 100 metres of row.
