## **DIRECTIONS:**

MILKING PARLOUR AND MILKING ROOM: To kill house flies, stable flies and gnats. Close all windows and doors. Spray at the rate of 1 to 2 seconds per 30 cubic metres. If room cannot be closed tight, double the dosage. Stand in the middle of the room, spray upward to fill the room with mist. Seconds may be counted by saying 1 thousand, 1 thousand 1, etc. Keep room closed for 15 minutes before ventilating.

EXAMPLE: A room 6 metres long by 3 metres wide and 2 metres high requires 1 second if closed tight, 2 seconds if not. Do not remain in treated areas. Ventilate the areas after treatment is completed.

BEEF AND DAIRY CATTLE: To kill house flies, stable flies and horn flies. Spray animals once daily with a fine mist, using 30-50 grams (spraying for approximately 45-85 seconds) per animal. Treat dairy cattle before milking, but do not spray directly on udders. Wash udders before milking. After one week, treatment may be reduced to once every second day.

PRECAUTIONS: Cover milking utensils and milk to prevent contamination from spray and dead-falling insects. Avoid inhalation. Avoid skin contact. Do not contaminate food, feed or water troughs. Do not contaminate any body of water. Remove all animals from barns/buildings before fogging. Ventilate treated area thoroughly for at least 30 minutes before animal re-entry.

Disposal: Dispose of empty container in household garbage. For information on the disposal of unused, unwanted product and the clean up of spills contact the regional office of Conservation and Protection, Environment Canada.

CONTENTS UNDER PRESSURE: Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50'C.
