DIRECTIONS FOR USE: Shake well before using. Hit insects directly with spray - insects must be hit to be killed.

Crawling Insects: To control ants, cadelles, crickets, clovermites, cheese mites, confused flour beetles, cigarette beetles, cockroaches, drugstore beetles, granary weevils, grain mites, meal worms, red flour beetles, saw-toothed grain beetles, spider beetles, spiders and silverfish: Use a good sprayer adjusted to deliver a coarse wet spray. Direct the spray into hiding places, cracks and crevices, inside empty shelves and drawers.

To Control Carpet Beetles: Spray edges of carpeting and under carpeting and rugs. Make localized application to floor and baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat treatment as needed.

To Control Fleas: Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, mouldings, window and door frames, and localized

areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. Concurrent treatment of animals with an insecticide registered for use on pets is recommended. Repeat treatment as needed.

To Control Clothes Moths: Remove any infested articles from storage, brush thoroughly and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus, and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated lightly keeping nozzle at least one meter from fabric to avoid staining.

Flying Insects: For drosophila, flies, gnats, and mosquitoes, close doors and windows. Spray upward to fill the room with a fine mist. Use a rate of 3-6 millilitres per cubic meter.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid breathing of spray mist. Do not contaminate food, feed or water. Wash exposed skin after handling. Remove pets, birds and cover or remove fish aquariums, food and food utensils before spraying. This product is toxic to fish. Do not contaminate ponds or streams.

FIRST AID: If in eyes, flush with water. If on skin wash with soap and water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once.
