DIRECTIONS FOR USE:

Mix thoroughly, one part of this CONCENTRATE with 99 parts by weight of a cereal type bait material such as corn meal, and/or rolled oats. A small amount of an edible oil such as mineral, corn or peanut oil may be used up to 3% to prevent dusting or to increase acceptability.

DIRECTIONS FOR USE: Use finished bait to control the house mouse, (*Mus musculus*) Norway rat (*Rattus norvegicus*) and roof rat

(Rattus rattus) in and around dwellings, farm buildings, food service establishments, granary bins (empty), processing plants (feed, food, non-food), storage areas (feed, food, non-food).

GENERAL: Place finished bait in locations frequented by rodents, such as tunnels, feeding areas and runways. For rats, place 100-500 g of bait per station. For mice set out about 50 g of bait at intervals of 2-3 m. Maintain an uninterrupted supply until feeding ceases.

CAUTIONS: KEEP OUT OF REACH OF CHILDREN. If taken in large or repeated doses by human or animals, it may reduce the clotting ability of the blood and cause internal bleeding. Place baits in protected places inaccessible to children, domestic animals or in tamperproof boxes. Do not contaminate food or feed. Do not contaminate any bodies of water. Burn or bury bodies of dead rodents.

SYMPTOMS OF POISONING

FIRST AID: If swallowed give patient one or two glasses of water and cause vomiting by inserting finger down throat; repeat until vomit fluid is clear. Call a physician.

TOXICOLOGICAL INFORMATION: Blood transfusions combined with intravenous injections and oral doses of vitamin K1 are indicated, as for hemorrhage by overdose of dicumarol.
