Basic-G(R) is specially formulated to reduce the hazard of cross-infection from environmental surfaces, a major housekeeping concern, not only in hospitals, but also in schools, institutions and industry. Basic-G cleans with biodegradable agents while it disinfects and is even virucidal when used as directed. Basic-G will deodorize toilet areas, behind and under sinks and counters, and garbage cans, and will inhibit the growth of mould and mildew and their odours when used as directed.

DIRECTIONS FOR USE: May be used in the presence of moderate amounts of organic soil. Apply Basic-G to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks and bedframes with a cloth, mop or Shaklee Spray Unit so as to thoroughly wet the surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Sanitizing - To sanitize porous or non-porous, non-food contact surfaces (floors, walls, tables, etc), add 1.5 mL to 1 litre of water. Allow treated surfaces to remain wet for 30 seconds. Basic-G is effective in waters up to 600 ppm hardness against Staphylococcus aureus and Klebsiella pneumoniae in the presence of 5% serum on porous and non-porous environmental surfaces.

Disinfection - To disinfect hard, non-porous surfaces, add 4 mL to 1 litre of water. Treated surfaces must remain wet for 10 minutes. Do NOT mix Basic-G with other cleaners as they may reduce its germicidal effectiveness. Rinse food contact surfaces with potable water before re-use. At this use-level, Basic-G is also virucidal* and fungicidal**. Used as directed, Basic-G has been found to be effective in the presence of 5% serum against the following by the AOAC Use-Dilution Test: Pseudamonas aeruginosa, Staphylococcus aureus, Salmonella choleraesuis, Escherichia Coli, Klebsiella pneumonias, Enterobacter aerogenes, Salmonella schottmuelleri, Streptococcus faecalis, Shigella

dysenterise, and Brevibacterium ammoniagenes. Fungicidal performance Trichophyton mentagrophytes (the athlete's foot fungus) was determined by the AOAC Fungicidal Test. Use on surfaces in locker rooms, shower rooms and bath areas, exercise areas, dressing rooms, etc.

- * Basic-G is virucidal on inanimate environmental surfaces against Herpes Simplex (a member of the virus family that causes infectious mononucleosis), Vaccinia (representative of the pox virus), and Influenza A2 (the Hong Kong flu virus).
- ** Basic-G inhibits the growth of mould and mildew and the odours caused by them when applied to hard, non-porous surfaces as directed above. Allow to dry on surface and repeat when mildew growth returns.
