**DIRECTIONS FOR USE:**

Use any type of hand sprayer which provides a cloud of fog-like mist. FOR FLIES, MOSQUITOES, GNATS AND MOTHS: Close doors and windows. Spray freely toward ceiling in all directions until room is filled with mist. Apply 30-60 mL per 28.3 cu meters of space. Keep room closed for at least 15 minutes after each treatment and before ventilating. Ventilate treated areas before reentry.

WASPS: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places. Whenever possible spray directly on the insect. Repeat as necessary.

**DISPOSAL:** Do not re-use empty container. Wrap and dispose of empty container with household garbage.
