DIRECTIONS FOR USE: Shake well before using. To protect horses from attacks of Stable Flies, Face Flies, House Flies, and Horn Flies. Holding container upright, apply 55 mL as fine mist directly to horse, being careful to spray back, withers and forelegs thoroughly. Do not spray on face. To protect from Face

Flies, spray onto a cloth and wipe on face avoiding eyes, nose and mouth. Repeat treatment daily, if necessary. Not to be used on newborn or nursing fouls. Do not soak skin. Do not cover horses immediately after treating. Do not apply to back of animal prior to saddling.
