DIRECTIONS

Shake well before using. Hold can upright while spraying. To kill house pests:

FLYING INSECTS - Flies, mosquitoes, wasps, gnats and flying moths. Close doors and windows. Direct mist upwards in sweeping motion to all parts of the room especially windows and other light sources. Apply 6-10 seconds burst per 30 m<sup>3</sup> of space. Whenever possible, keep doors and windows closed for 15 minutes

after each treatment. Direct mist into areas where insects are present. Keep spray at least 1m from interior wall, fabrics and furniture.

CRAWLING INSECTS: Cockroaches, spiders, crickets, ants, carpet beetles, centipedes and silver-fish. Spray hiding places such as base boards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Spray ant trails, around door sills, window frames, or in ant nests. Insects must be hit to be killed.

BED BUGS: Spray mattress, particularly around seams and tufts. Take beds apart and spray all joints. Repeat as required.

FLEAS: Spray sleeping quarters of pets.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50 deg C. Cover fish bowls and remove pets for one hour when spraying rooms. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Avoid contact with skin, eyes, clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use on maiden hair ferns. Do not use on vegetable crops.

DISPOSAL: When container is empty, press button to release all pressure, then dispose in household garbage. Do not puncture or incinerate.

TOXICOLOGY AND FIRST AID: Avoid inhalation or exposure of concentrate to eyes. In case of contact, flush with plenty of water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once.
