PYRONIDE 33 PLUS, a ready to use insecticide can be applied as a surface or space spray to control flies, tobacco moths, tobacco beetles, Indian meal moths, flour and grain beetles, grain and rice weevils, cockroaches, spiders and silverfish.

DIRECTIONS:

As a space spray application should be carried out at weekly intervals depending upon the rate of infestation. Apply PYRONIDE 33 PLUS at a rate of 100-200 mL per 100 cubic m with a machine that produces an aerosol mist. When using a thermal fog generator, apply no more that 325 mL per 100 cu. metes. Ventilate the building before re-occupancy. As a surface spray apply at an even rate of 5 L per 100 square m. Spray must contact insects to control.

PRECAUTIONS:

Handle and spray only as recommended and at recommended rates. Keep product away from fire, open flame, lighted electric bulbs, and other sources of heat. Do not use oil based sprayed on tiled floor surfaces or rubber backed rugs. Cover exposed food or produce and equipment. Only spray when plant is not in operation. Avoid contamination of food, feed and water supplies.

In food processing and food service establishments, apply only when plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operation.

For meat packing plants, treat only when plant is not in operation. No exposed meat products to be left in the room and cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing.
