INDUSTRIAL LIQUID SLIMICIDE

TO PREVENT ALGAE, SLIME, AND FUNGI IN RECIRCULATING COOLING WATER

DIRECTIONS FOR USE:

Add separately to system. Do NOT mix with other chemicals.
Introduce through chemical pump/tank on feeder leading to

recirculating line or direct to sump. Badly fouled systems should be mechanically cleaned before treatment is begun. Initial shock dosages of 200 to 300 ppm IPC 8925C are recommended. Repeat initial dosage until control is evident. After control is achieved, dosages may be reduced to 120 to 200 ppm IPC 8925C. Apply treatment once or twice a week or as needed to maintain control.

PRECAUTIONS: This formula may cause skin irritation or damage to eyes. Harmful if swallowed. Avoid contact with eyes, skin, or clothing. Wear suitable eye protection and protective gloves when handling. Do NOT reuse empty container. Keep container closed when not in use.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Do not discharge effluent containing this active ingredient into lakes, streams, ponds, estuaries, oceans, or public waters. Do not contaminate water by cleaning of equipment or disposal of wastes.
