DIRECTIONS FOR USE: For general control in recirculating cooling water systems, feed 10-150 mg/L (ppm) once to twice per week as required.

For continuous feeding, use 3-8 mg/L (ppm) based on makeup.

Do not use in potable water supply.

Do not mix as a concentrate in combination with strong oxidizing agents.

PRECAUTIONS: Wear suitable face and hand protection when handling. Avoid getting in eyes, nose or on skin. Do not take internally. Keep away from open flame or excessive heat. Remove contaminated clothing and wash before reuse. Avoid contamination of food.

FIRST AID: In case of contact with skin, wash skin thoroughly for 15 minutes. If contact is made with eyes, flush well with water and get medical attention.
