#### DIRECTIONS FOR USE:

COOLING TOWERS ANCOCIDE 4070 is recommended for the removal of slime from fouled towers, add 0.33 to 8.67 kg of ANCOCIDE 4070 as supplied per 10 tonnes of water in the system (equivalent to about 0.5 to 13 ppm active ingredient). This dosage should be repeated 12 to 3 times per week until fouling has been reduced to an acceptable level thus establishing microbial control.

#### POINT OF ADDITION:

ANCOCIDE 4070 should be added to the basin to the distribution boxes, or at any other point where it will be rapidly and uniformly dispersed throughout the system.

#### FIRST AID:

Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician

immediately.

IF INHALED:

Remove immediately to fresh air. If not breathing, apply artificial respiration. If breathing is difficult, give oxygen. Call a physician.

IN ON SKIN:

Wash thoroughly with soap and water remove, wash contaminated clothing before reuse.

IF IN EYES:

Flush with plenty of water for at least 15 minutes. Call a physician.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions, may be needed.
