PRECAUTIONS:

Keep out of reach of children.

CORROSIVE to Eyes. May cause irritation to nose, throat and skin. Harmful if swallowed, inhaled or absorbed through skin. Do not get in eyes. Protect eyes when handling concentrate. Avoid contact with skin or clothing. Avoid breathing dust or spray mist.

This product is toxic to fish. Treated effluent should not be discharged where it will drain into lakes, streams or ponds.

Do not reuse empty container. Destroy when empty.

FIRST AID INSTRUCTIONS: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Call a physician immediately.

#### DISPOSAL

1. Rinse the emptied container thoroughly and add the rinsings to treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
3. Dispose of the container in accordance with provincial requirements.
4. For information on the disposal of unused, unwanted product and the cleanup of spills contact the regional office of the Conservation and Protection Service, Environment Canada.
5. For small spills. Recover free liquid. Soak up residue with solid absorbent. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA AS IN #4.

#### DIRECTIONS FOR USE:

Mold resistant paper and paperboard: To impart mold resistant properties to paper or paperboard, apply VANCIDE 51Z as a surface treatment on size press or calender stack, diluted as required, to retain 0.5% solids based on the weight of the sheet. See TAPPI Standard T487M-54 for mold resistance evaluation method.

Not for use in the production of paper or paperboard coming in contact with food.

Preservation of paper coatings: To preserve paper coatings add

0.1% VANCIDE 51Z by wight of dry starch of protein.

Fungus-resistant latex coated articles: Add VANCIDE 51Z to the latex before coating, using 0.25% by weight of the completed article. For coated cotton fabric it is recommended that the fabric also be treated with VANCIDE 51Z before coating using 1.25% by weight of the cloth.

Mold inhibitor in latex paints: For exterior latex paints, use 1-3% VANCIDE 51Z based on total paint weight. Do not use in formulations containing metallic drier.

Textile mildew and bacterial growth inhibition: Apply 0.55% to 0.8% VANCIDE 51Z by weight of the goods to protect cotton textiles from growth of mildew in mattresses, pillow covers, canvas shoes and shoe liners. This treatment is also useful on cotton batting for use in mattresses and upholstery. Apply 0.55% to 0.8% VANCIDE 51Z to these same cotton goods to prevent development of bacterial growth, to maintain freshness and for sanitary reasons.

Preservation of industrial yarns and fabrics: For long-term protection of industrial yarns and fabrics from mildews, rots and bacterial decomposition, use 1.25% ± 0.25% VANCIDE 51Z based on the material applied in water dispersion.
