DIRECTIONS: Adjust spray nozzle to give desired pattern. Spray infested surface only until wet. Do NOT use as a space spray. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish aquariums before spraying. Do not apply sprays of this product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared. If reinfestation occurs, repeat

treatment.

DO NOT TREAT PETS WITH THIS PRODUCT. To control the source of flea infestations, pets inhabiting the treated premises should be treated with a product registered for application to animals.

FOR CONTROL OF FLEAS AND BROWN DOG TICKS(Indoors). Thoroughly treat cracks and crevices, along and behind baseboards, windows, door frames, and as a spot treatment to infested areas such as pet beds and resting quarters and in localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area.

FOR CONTROL OF CARPET BEETLES(Indoors). Apply as a SPOT treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets, and on shelving, or wherever these insects are seen or suspected.

FOR CONTROL OF ROACHES, ANTS, CLOVER MITES, CRICKETS, FIREBRATS, SILVERFISH AND SPIDERS(Indoors). Thoroughly treat cracks and crevices under and behind sinks, stoves, refrigerators, cabinets, cracks and crevices in walls and floors. For ants, apply to ant trails, also around doors, windows or wherever these pests may gain entrance.

PRECAUTIONS: Avoid contact with eyes, skin, clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs and domestic water supplies. Wash thoroughly after handling. Do not use or store near heat or open flame. Do not store below 0 deg C. Do not apply to plants, animals, or humans.

DO NOT CONTAMINATE FOODSTUFFS. Do not use in any area where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboards where food or cooking utensils are stored. In homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before reuse.

FIRST AID: In case of poisoning, call a physician immediately.  
NOTE TO PHYSICIANS: Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal. 2-PAM is also antidotal and may be used in conjunction with atropine but should not be used alone.

STORAGE AND DISPOSAL: Avoid contamination of food or feed. When empty container is discarded, wrap container and discard with household garbage.
