MOSQUITOES, WASPS, HORNETS, GNATS, FLYING MOTHS, SANDFLIES,  
SILVERFISH, COCKROACHES, CRICKETS, BOX ELDER BUGS, CLOVER MITES,  
CARPET BEETLES, AND STORED PRODUCT INSECTS: Treat areas at a  
rate of 1 second spray per 90 sq.m.

In buildings, close all doors and windows, and spray upwards in the entire room. Hold container 1 m from walls, fabrics or other surfaces. Keep room closed for 15 minutes. For crawling insects, spray directly into cracks and crevices where insects hide or enter. Hit insects directly with the spray where possible. For wasps and hornets use double the rate.

ORNAMENTAL TREES, SHRUBS, FLOWERS AND HOUSE PLANTS: Spray lightly on plants from a distance of 45 cm to control insects. Do not treat during bloom. Spraying too heavily or too close to plant may cause damage.

PRECAUTION: Avoid inhaling mist. Avoid contact with skin, eyes and clothing. Keep out of reach of children. Contents under pressure. Do not expose to heat. Do not puncture container or incinerate. Cover fish bowls and remove birds for 1 hour. Cover exposed food and utensils.

FIRST AID: For external contact, wash with soap and water. If in eyes, flush with plenty of water. If swallowed, induce vomiting by placing a finger at the back of the throat. Repeat until vomit fluid is clear. Obtain prompt medical attention.
